The Muscatine County Board of Supervisors met in regular session at 9:00 A.M. with Holliday, Sauer, Mather and Sorensen present. Chairperson Saucedo presiding.

On a motion by Sorensen, second by Holliday, the agenda was approved as presented. Ayes: All.

Auditor Vander Linden will revise the minutes to the corrected statement by Saucedo.
