The Muscatine County Board of Supervisors met in regular session at 9:00 A.M. with Sauer, Mather, Sorensen and Saucedo present. Holliday was absent. Chairperson Saucedo presiding.

On a motion by Sorensen, second by Mather, the agenda was approved as presented. Ayes: All.

On a motion by Sorensen, second by Sauer, the Board approved the claims dated April 19, 2021 in the amount of \$2,246,397.07. Ayes: All.

Mike Nolan of Horizon Architecture presented the bids received by 10:00 A.M. on April 15, 2021 for the Muscatine County Attorney's Office Remodel Project as follows: Spectra Build - \$308,700.00; THCC - \$337,000.00; Swanson Construction - \$407,000.00. Lejas Corporation submitted a bid with no Bid Bond provided. Nolan recommended the bid from Spectra Build. On a motion by Sorensen, second by Mather, the Board accepted a bid with Spectra Build for the Muscatine County Attorney's Office Remodel Project in the amount of \$308,700.00. Ayes: All. Nolan stated the time-line of the remodel project is yet to be determined with Spectra Build and he will request the start of project be in summer 2021 and be finished by fall 2021.

On a motion by Sorensen, second by Sauer, the minutes of the April 12, 2021 regular meeting were approved as written. Ayes: All.
